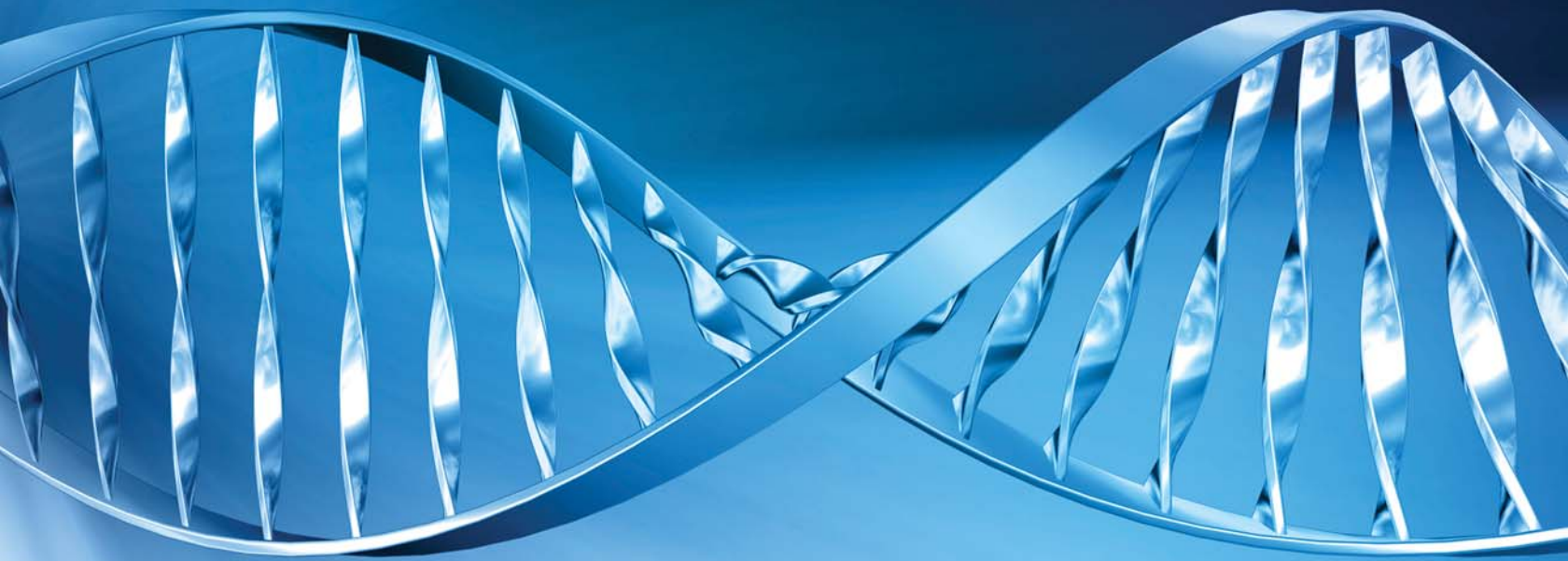

Biography - Eric Merola (Writer, Director, Producer)

Eric Merola began his career as a motions graphics designer and animator for various TV & film clients including WE Network, Fuel TV and Speed Channel. He also worked on projects for A&E, Comedy Central and MoveOn as animation director for Flickerlab in New York City. And in 2007, while building an animated sequence for Michael Moore’s CAPITALISM: A LOVE STORY, Merola became aware of Stanislaw Burzynski and felt compelled to tell his story.

Spanning three years, Merola produced, wrote and directed his debut documentary, BURZYNSKI (2010). It attracted widespread distribution and numerous awards including Best Documentary 2011 on the Documentary Channel and 2 Audience Awards at the HumanDoc Festival in Warsaw 2011. It also received favorable reviews from The Los Angeles Times, The New York Times and Variety, and celebrity endorsements from Anthony Robbins, Dr Oz, Josh Duhamel, and Fabio Lanzoni.
