BEFORE ME, the undersigned notary public, on this day personally appeared Stanislaw Rajmund Burzynski, M.D., 6221 Corporate Drive, Houston, Harris County, Texas 77036, who, after being by me duly sworn, upon his oath, deposed and said:

I, Stanislaw Rajmund Burzynski, M.D., of 6221 Corporate Drive, Houston, Harris County, Texas, and holder of Texas Medical License Number D-9377, did appear at the office of the Texas State Board of Medical Examiners on August 11, 1986, with counsel, John T. Johnson, in response to the written request of the Board dated July 28, 1986, to discuss my use of antineoplastons in the treatment of cancer.

After presentation of evidence regarding the above matters to the Hearing Officer for the Board, Bill Campbell, J.D., and John C. Bagwell, M.D., Board member, and upon counseling and recommendation by the said Hearing Officer and Board member, I voluntarily state and affirm as follows:

- 1. I agree to present to the Texas State Board of Medical Examiners a list of 40 cases of various types of neoplastic diseases to be selected by me and which patients were treated by me, which I expect at this time to include various patient histories who had been previously diagnosed as having cancer of the breast, cancer of the bladder, cancer of the lung, cancer of the liver, cancer of the brain, cancer of the head and neck, malignant lymphoma, and any other neoplastic disease cases I might wish which will contain the following complete data:
 - a. A pathological report.
 - b. A brief history prior to the patient being seen by me.
 - c. The pertinent laboratory data when the patient saw me.
- d. The treatment course, including what drugs were given, and for what period of time.
- e. The evidence suggesting an objective response. Objective response would be defined as a measurable decrease of a size of perimeters which demonstrate the presence of a malignancy, especially complete responders (those patients with total disappearance of disease), and partial responders (those patients with at least 50% but not total improvement in the objective measurements). Objective response shall also include stabilization of the expected tumor growth in the particular cancer or a slowing or a reduction in the normal expected rate of growth increase of the particular type of malignant neoplastic tumors being treated in the patients. It is also understood that I also administer to some patients, on occasion, low doses of conventional chemotherapy in

combination with Antineoplaston Drugs when, in my medical opinion, it is necessary for the patient's treatment.

I will present one-fourth of the above data by January 1987, and all of the data by May 1987. This data, in turn, will be presented to an individual oncologist licensed in the State of Texas for his/her review. I shall present the Board with a short list of oncologists who are not acceptable to me. Attached hereto as Exhibit "A" is a list of oncologists and medical doctors not acceptable to me for reviewing these medical records. The Board will appoint and shall have complete discretion in choosing the oncologist who will review the data.

After review, if the oncologist and the Board are satisfied that there has been some effectiveness in my therapy, this affidavit will be terminated and held for naught. However, if such effectiveness cannot be confirmed, the Board may file a complaint against me under Section 3.08 of the Medical Practice Act.

- 2. I voluntarily state that I will cooperate with the Texas State Board of Medical Examiners, its attorneys, investigators, and other employees, in the investigation of my practice to verify that I have complied with this affidavit.
- 3. I agree to advise the Texas State Board of Medical Examiners of any change of address, mailing or office, within ten (10) days of such occurrence.

I agree that I shall comply with all the provisions of Article 4495b, Texas Civil Statutes, and other Statutes regulating the practice of medicine, as are required by law for physicians licensed by the Texas State Board of Medical Examiners.

I recognize that if I do violate any of the provisions of this affidavit or Article 4495b, Texas Civil Statutes, I could be cited to appear before the Texas State Board of Medical Examiners in a formal disciplinary hearing for such violations which could result in cancellation of my license to practice medicine.
